BREED SOCIETY STANDS - INFORMATION AND CONDITIONS

1. Ensure that the size of stand required is sufficient to provide for display material and pens of sheep.
NO CARAVANS UNDERCOVER.
2. State if any additional facilities are required for your stand.
3. Access for erection of stands will be from 11am to 6.30 pm on Thursday 8th February and from 8.00 am to 9.00 am on Friday 9th February, All non-exhibition items and cars must be off site by 9.45 am on the day of the event. All articulated vehicles unloading stand equipment for indoor stands must be unloaded on Thursday 8th February. Stands can be removed after 5.00 pm on the day of the event and must be cleared no later than 8 pm on the event day. **NOTE: ALL STOCK FOR DISPLAY ON STANDS MUST BE DELIVERED TO EVENT ON FRIDAY 9TH FEBRUARY BY 9.00 AM, NO ACCESS FOR STOCK AFTER THIS TIME.**
4. No exhibitor shall be permitted to arrange their stand or to place their sign in such a manner as to obstruct the light or to inconvenience or disadvantageously affect the display of any other exhibitor. No form of intrusion into neighbouring sites will be permitted.
5. Each exhibitor must provide a fire extinguisher, and will be responsible for the removal of refuse from their stand.
6. No person, other than the exhibitor who has applied for and been allocated space, shall be allowed to sell or display articles of any description on the ground.
7. Stand Holders will be sent two free exhibitor passes up to 10 feet frontage and four free passes over 20 feet frontage booked. Three extra passes can be obtained for a total of £5 plus vat at time of booking space. Two vehicle passes will be issued to allow access.
8. **STATUS OF SHEEP DISPLAYED ON INDOOR AND OUTDOOR STANDS MUST BE STATED, MV ACCREDITED OR NON-MV ACCREDITED.**
9. **ALL SHEEP ON STANDS MUST HAVE BEEN TREATED WITH A SCAB PRODUCT.**
10. Staffing of stands must be at all times between 10.00 am and 5.00 pm on Friday 9th February 2018.
11. The event does not provide straw or feed for the sheep, please ensure that you bring your usual feed with the sheep. Water will be provided.
12. Hurdles/gates will be available for Sheep Breed Society use only.
13. The sole catering and bar rights have been granted.
14. The National Sheep Association (The Association) will not be responsible for any accident, damage or loss however caused, which may occur to any exhibitor or to his animals, articles or property brought onto the site. The Association will not be responsible for any actions or expenses on account of or in respect of any such damage or injury caused. All exhibitors must have Full Third Party Liability insurance and, if requested, will supply proof of current policy to The Association. All exhibitors indemnify The Association from any claims made in connection with the exhibitor's staff, equipment, display, animals or vehicles.

The decision of the Organising Committee about the interpretation of these conditions will be final.
