#### **TRADE STANDS – INFORMATION AND CONDITIONS**

1. Stand charges are listed on the application form. Please indicate clearly the size of stand required.
2. The closing date for stand applications is MONDAY 4TH DECEMBER 2017. Applications received after this date will be subject to space availability.
3. Each company shall exhibit only or mainly materials and products of relevance to agriculture and related industries.
4. No exhibitors shall be permitted to arrange their stand or to place their sign in such a manner as to obstruct the light or to inconvenience or disadvantageously affect the display of any other exhibitor. No form of intrusion into neighbouring sites will be permitted.
5. Electricity can only be provided for inside stands as indicated on the application form. Water standpipes will be available on site.
6. All indoor stand space is on clean, flat concrete. Outdoor space is available on hardstanding. Exhibitors with marquees must provide the organiser with a fire resistant certificate. All ground must be completely restored on removal of stands.
7. Exhibitors shall furnish their stand with a fire extinguisher. Exhibitors shall be responsible for the removal of refuse from their stand.
8. Stand Holders will be sent two exhibitor passes free up to 10 feet frontage and four free passes over 20 feet frontage booked. Three extra passes can be obtained for a total of £5 plus vat at time of booking space. Two vehicle passes will be issued to allow access.
9. Access for erection of stands will be from 11am to 6.30 pm on Thursday 8TH FEBRUARY 2018 and from 8.00 am till 9.30 am on Friday 9TH FEBRUARY 2018, All non-exhibition items and cars must be off site by 9.45 am on the day of the event. All articulated vehicles unloading stand equipment for indoor stands must be unloaded on THURSDAY 8TH FEBRUARY. Stands can be removed after 5.00 pm on the day of the event and must be cleared no later than 8.00 pm on the event day. NOTE: ALL STOCK FOR DISPLAY ON STANDS MUST BE DELIVERED TO EVENT BY FRIDAY 9TH FEBRUARY BY 9.00 AM, NO ACCESS FOR STOCK AFTER THIS TIME.
10. Staffing of stands must be at all times between 10.00 am and 5.00 pm on Friday 9th February.
11. No person other than an exhibitor who has applied for and been allocated space will be allowed to sell or display articles of any description on the site. Sub-letting of stands is not permitted.
12. The sole catering and bar rights have been granted.
13. The National Sheep Association (The Association) will not be responsible for any accident, damage or loss however caused, which may occur to any exhibitor or to his animals, articles or property brought onto the site. The Association will not be responsible for any actions or expenses on account of or in respect of any such damage or injury caused. All exhibitors must have Full Third Party Liability insurance and, if requested, will supply proof of current policy to The Association. All exhibitors indemnify The Association from any claims made in connection with the exhibitor's staff, equipment, display, animals or vehicles.
14. The decision of the Organising Committee about the interpretation of these conditions will be final.
