## Request and approval form for release of semen from the Ovine Semen Archive (OSA) and transfer of ownership

Please read this information and the terms and conditions before completing the form. Instructions for returning the form are at the end of the document.

Between November 2020 and August 2022, the contents of OSA were as thoroughly reviewed and rationalised, meaning there is very little within the archive that is surplus to requirements. However, where more than 50 straws for a single ram are held, a request can be made to release semen. ## Terms and conditions of release

Anyone completing and signing this form agrees to the following terms and conditions.

- No request is guaranteed. The OSA Board rules on each individual request for release of semen and transfer of ownership; that decision is final and will be based in part on scrapie genotype (more below) and quantity of semen held.
- If a request is agreed, there is no charge for the semen. However, all costs of transferring the semen (currently held by AB Europe) will be invoiced to the individual making the request and must be paid in advance of the semen being moved.
  - Transfer costs to an on-farm or other alternative facility are £40/ram plus a £25 administration fee plus VAT.
  - To transfer semen out of OSA but still to be stored by AB Europe, the cost is £20/ram plus a £25 administration fee plus VAT.
- The quality of the semen transferred cannot be guaranteed and there is no recourse if problems are identified after ownership has been transferred. Transfer of ownership is at the point the semen leaves OSA. Transfers will be undertaken by AB Europe, within its standard procedures. Please request this information from AB Europe.
- Semen in OSA was collected as part of the National Scrapie Plan and, therefore, is all scrapie susceptible (i.e. no group 1 rams are held within OSA). Group 2 and 3 rams will be considered for release for commercial use but OSA urges responsibility when integrating the semen into breeding programmes. Group 4 and 5 rams will not be considered for release for commercial use but may be considered for research programmes.
- If a request is agreed, OSA cannot guarantee the relevant breed society will register any resulting progeny; individuals using the released semen are advised to check with the appropriate breed society beforehand. Please be aware that no progeny will be eligible for export outside the UK, due to its scrapie status.
